1,500 women rejected

OTTAWA (CP) - A senior insurance executive, an economist and a top counsellor with one of Canada's largest investment firms were among 1,500 women rejected as prospective members of the Royal Bank's board of directors, a bank shareholder said Friday.

Ruth Bell, also a past president of the Canadian Federation of University Women, said a list of 1,500 names was compiled from the federation's roster of qualified women and submitted to bank president W. Earle McLaughlin as suggestions for board members.

The list included many women with business experience, Mrs. Bell said.

Mr. McLaughlin said earlier this week that a cross-Canada search failed to produce the names of any women with sufficient qualifications for the position. He said the bank has been under pressure from women's organizations to appoint a woman to the 48member, all-male board, but the women have failed to make any constructive recommen-

Women ordination supporter elected

MINNEAPOLIS (AP) - A church leader who favors ordination of women as priests won election as vice-president of the House of Deputies at the United States Episcopal Church's national convention

Charles Lawrence of Pomona, N.Y., chosen as vice-president over two other candidates, said his support of women's ordination probably helped elect him to the post, one of the church's top offices.

'I would not be surprised if it did to some degree," he said, predicting approval at the church's triennial national general convention of the controversial move to authorize ordaining women.

Women are not specifically banned from being priests in the Episcopal Church, but tradition has kept the priesthood all male.

The election of Lawrence puts him in a position to succeed Dr. John Coburn, bishop-elect of Boston, as president of the House of Deputies, a post to be filled Sept. 23 at the end of the 13-day convention.

Dr. Coburn steps down then to take up his new bishop's office after nine years as head of the 912-member House of De-

Lawrence, 61, black and a sociology professor at Brook-lyn College in New York City, won the vice-presidency with 413 votes to 346 for Walker Taylor of Wilmington, N.C.,

and 44 for Mrs. Seaton Bailey of Griffin, Ga.
