Civil servants angry with minister's wife

OTTAWA - Barbara McLean, wife of minister of state for immigration Walter McLean, has angered and frustrated senior civil servants by participating at meetings of federal officials who report to her husband and approaching others as if she were acting in an official capacity.

Sources within the immigration department and secretary of state's department (which McLean headed before a cabinet shuffle August 20) have confirmed that his wife also attended the first briefing session that McLean had with the deputy minister of immigration, Gaetan Lussier, after being sworn into his current job last summer.

Sources have told Southam News that, at a meeting on the day of McLean's swearing-in as junior immigration minister, Lussier was stunned by the intervention of McLean's wife and her insistence on raising questions about immi-

gration department policy. They also said that incoming Secretary of State Benoit Bouchard had a similar reaction earlier that day, during a luncheon meeting at which Mrs. McLean expounded at length about the way that department should be run.

McLean, in an interview with Southam News, confirmed that his wife had attended both meetings, but insisted there was nothing irregular about them. He also angrily denied that she had ever interfered in government matters that

did not concern her. "This just is not true," he said.

"My wife doesn't even live here (in Ottawa), McLean said. "She lives in the riding (of Waterloo, Ontario). When she comes, which is infrequently, she has some cour-

But some government employees insist that these contacts are far more extensive than McLean acknowledges and that Barbara McLean has even acquired a nickname among senior immigration department officials and ministerial aides.

"She's known as 'The General.' said one political aide to another cabinet minister in the Mulroney government.

McLean's former chief of staff. Michele Bedard, also confirmed that Mrs. Mclean had attended meetings with Bouchard and Lussier the day of last summer's cabinet shuffle.

Bedard, who now serves as Prime Minister Brian Mulroney's adviser on women's issues, also said that there were several occasions on which McLean's wife conducted business within offices of the secretary of state's depart-

"Mrs. McLean is a business woman and handling some of her husband's personal affairs, like a family portfolio," Bedard said.

"So because of that, she was at times in the department, but as far as attending meetings, strictly on official business, no not that I re-

Bedard said people should understand that the McLeans have an extremely close working relation-

"This is behavior that is familiar to them and might not be familiar to everybody, or accepted in that sense. We have to be balanced in our judgment and not take only one side of it," Bedard said. In Toronto, Steve Patten, who

worked until a few months ago as a constituency liaison aide for McLean, added of Mrs. McLean: "She is a strong presence, because of the personality she's got.'

"And even when she doesn't have a presence around the office, she has a strong presence with him," said Patten, who is currently working as an organizer for Ontario Conservative leadership candidate Larry Grossman.

Gulf tax deal stays secret

OTTAWA (CP) — A tax ruling that may allow Gulf Canada Ltd. a tax break of more than \$1 billion is confidential and cannot be discussed by a parliamentary committee, Finance Minister Michael Wilson said Tuesday.

Liberal Leader John Turner and Liberal finance critic Don Johnston asked Wilson to refer the controversial ruling to a Commons committee so that the public can learn exactly how much the company will save.

Johnston said the government is hiding behind the provisions of confidentiality in the Income Tax Act to deny Canadians information on how much the ruling will end up costing the federal treasury.

"Does the Income Tax Act condone secret and cozy deals?" Johnston asked, saying the

ruling had provided a gift of \$1 billion to a few wealthy Canadians.

Toronto's Reichmann family, through their

holding company, Olympia and York Developments, obtained the ruling from the Revenue Department when it purchased a majority interest in Gulf Canada.

Olympia and York then transferred most of Gulf's assets into a partnership it set up with Norcen Energy Resources, controlled by Toronto financier Conrad Black.

Using the partnership allows Gulf and Norcen to increase the value of assets transferred to the partnership so they can be depreciated down for tax purposes.

As the assets have already been depreciated, the government would normally levy a tax - known as "recapture" - on the difference between the revalued price of the assets and the value they had previously been depreciated to.

Brian Felesky, vice-chairman of a Canadian Bar Association committee on tax law, says the partnership device allows a company to limit the amount of recapture while

allowing assets to be revalued. Oil industry analysts have put the amount of the tax savings which Gulf could earn through the device at more than \$1 billion.

Felesky says the partnership device is legitimate because the government would normally offset its loss of recapture through capital gains taxes.

He points out, however, that Gulf might be able to defer any payment of offsetting capital gains taxes.

Wide-ranging trade talks urged

SASKATOON (CP) — Canadians do not have to fear losing social programs like medicare or special trade agreements like the auto pact if they enter a free-trade agreement with the United States, Thomas Niles, U.S. ambassador to Canada, said Tuesday.

But they should expect to discuss sensitive areas like the entry of U.S. banks and securities firms into the Canadian economy, Niles told the annual meeting of the Canadian Chamber of Commerce in his first major public appearance

as U.S. ambassador here. He urged the Canadian business audience to support free-trade talks on the broadest possible basis, including potentially sensitive areas like banking, agriculture, publishing and broadcasting.

Much of the industrial production on both sides of the border is already free from tariff restriction or soon will be, he reminded them.

'It's true that by 1987, when the Tokyo round of GATT negotiations takes full effect, 95 per cent of Canadian industrial exports to the U.S. will enter at a duty of five per cent or less." About 86 per cent of U.S. industrial exports to Canada will enter at a similar rate, he

Asked at the news conference if this meant future free-trade talks would likely focus on areas seen as affecting Canada's national identity or regional development programs, Niles said, "Some of these areas could be involved.'

Niles said the United States is interested in areas like investment banking, which now is "practically impossible in Canada" for U.S. firms. But, he said, figures on industrial trade indicate trade flows both ways when restrictions, including state and provincial nontariff barriers, are lifted.

Meanwhile, Canadian business and political spokesmen told chamber delegates free trade with the United States is less risky than often presented, while a labor leader indicated he could live with free trade if it was properly handled.

Eighty per cent of Canada's trade with the United States is already tariff-free and the country's ability to design its own social programs has not been destroyed, said Robert Pierce, executive vice-president of Nova Corp. and vice-chair-man of a national task force on Canada-U.S. trade policy.

Tom Hockin, Conservative member of Parliament for London West and co-chairman of a parliamenta-

ry committee on international relations, said some potential disadvantages like the loss of economic development subsidies would affect the United States as well.

'We do subsidize some domestic activities that might assist exports, but too often, municipal tax breaks and state Buy Ohio procurement regulations in the U.S. accomplish the same for Americans," Hockin

Jim McCambly, president of the Canadian Federation of Labor, told the crowd his federation, dominated by construction unions, is more inclined toward "fair trade" or "enhanced trade" than free

Wrongly handled, free trade could cost jobs, he said.

While the panel discussion was held Tuesday, the chamber's ap-

proximately 200 voting delegates went on record Monday with a resolution supporting "the orderly phasing out of all or substantially all trade barriers" between the two countries.

The chamber's three-day meeting ended Tuesday after the election of Harold Milavsky of Calgary, president of Trizec Corp. Ltd., as chamber chairman.
